#### **REGULAR MEETING 5:30 PM**

Board President Bob Powell called the regular meeting of the Water District 19 Board of Commissioners to order at 5:30 PM. - Mathew Lawrence Camp Colvos Brewing. Mathew met with King County Department of Permitting and Environmental Review and was informed that he will need a Certificate of Water (CWA) for fire purposes. They will require at least 1500 gpm. He's just beginning the process and needed to touch base with the district on what is required for the CWA. **Commissioner Powell** explained the CWA requirements to Mathew. If just needing fire flow, that can be handled by the General Manager, if he needs the CWA for the building process then he'll need a stamped engineer's analysis of the project using the gpd figures tied to the property.
