- Commissioners were requested to review and sign a "Stipulation & Order of Dismissal with Prejudice" court document, if they deemed necessary. After review and discussion, it was unanimomusly agreed that they would not take any action. General Manager McRae will continue to minitor the suit. Commissoner Powell requested asking advice of the MRSC (.
- Water System Plan Chapter 8 (CIP) Review & Approval
 - **Worksheet Review** The capital expenditure planning worksheet was discussed & the board agreed to the projects and project timing as presented in the worksheet. The data in the worksheet lays out the capital spending and funding for the latest *Water System Plan*.
 - Worksheet Narrative The chapter narrative and graphics were discussed & the board agreed that Genaral Manager Manager would make the necessary edits to the worksheet. The narrative in the plan will be incorporated into latest *Water System Plan*.
- Water System Plan Chapter 9 (Finance) Review & Approval
 - **Worksheet Review** The financial models were discussed & the board agreed that Genaral Manager McRae would make the necessary edits to the worksheet. The narrative in the plan will be incorporated into latest *Water System Plan*.

- Commissioner Zuckerman made a Motion to increase Base Fees by 5% & Usage Fees by 13% to cover the increase in personnel expenses for its operators as a result of the Union contract that went in effect January 1, 2020; Commissioner Weller seconded. Motion passed unanimously.
- K2 request for an increase in Water Units was discussed based on 19 years of usage data. General Manager McRae was directed to communicate with their representative to see if there is agreement on the data used for the analysis and work towards a formal agreement.
